PURPOSE OF PROCESSING

Your personal data (*name, surname, date of birth, identification document details, access data*) are processed in order to: a) register your personal data on the software that manages the access register;

b) guarantee the traceability and management of security within the building, in the event of an emergency situation, while respecting confidentiality of your personal data.

DATA RETENTION PERIOD AND METHOPDS OF PROCESSING

Reception is equipped with a softare that records and archives visitors' personal data. The management and visualisation of personal data are restricted to the Data Controller and/or persons formally authorised. Data are stored with appropriate security measures to prevent access by unauthorised personnel and to guarantee their confidentiality and integrity.

Personal data relating to access and visitors' records will be stored for a period of 180 days (for children under the age of 18, the period is reduced to 96 hours) after the last access. Your data might be discosed to public authorities during rescue operations and for other purposes envisaged by the law. After the aforementioned retention periods have expired, data will be automatically deleted.

Your data will be processed exclusively by data processors idenitified by the contorller and by designated persons who have the possibility to access the data for the purpose of undertaking the processing operations.

RIGHTS OF THE DATA SUBJECT

You have the right to access your personal data and to rectify them in case your personal data are inaccurate or incomplete. Under certain conditions, you have the right to erase your personal data, to restrict the processing of your personal data, to object to the processing of your personal data and the right to data portability. You have the right to object to the processing of your personal data, which is lawfully carried out pursuant to Article 6(1)(e-f) on grounds relating to your particular situation. Insofar the processing of your personal data is based on your consent, you can withdraw your consent at any time by notifying the Data Controller. The withdrawal will not affect the lawfulness of the processing carried out before you have with drawn the consent.

You have the right to lodge a complaint with the competent supervisory authority. We will consider your request, take a decision, and communicate it to you.
